## Crystal Palace Band Treasurer's Report 2018 AGM

The band has again made a substantial surplus of over £1800 this year. As normal I report on total income

and expenditure for the band, but give prominence to 'regular income and expenditure' which deducts

the impact of accommodation money for trips to Butlins etc. These are selffinanced by members but are put through our accounts on a broadly break-even basis for bookings purposes. From the accounts overleaf you will see most area of expenditure and income have remained broadly similar to previous years. There are two exceptional items. Firstly, we again won prize money from Butlins - albeit our first year in the third section was not as lucrative ( $\pounds$ 700) as winning the fourth section last year ( $\pounds$ 2000). Secondly, the Gala Concert cost us a net  $\pounds$ 590 to stage which was well inside the Committees expected budget for such a commemorative event.

For this year's accounts I have included he cost of extra rehearsals in buildings with better acoustics under the Rehearsal Room Rent rather than allocate to Contest Expenses.

This gives a fairer reflection of the costs deriving from the limitations of the museum - as well as its advantages. Based on these healthy accounts I propose that membership subs are not increased, although they represent tremendous value compared to similar organisation. The Committee will be in a position to invest in the bands as this level or reserve is almost triple the annual regular running costs of the bands.

I regret that I'm unable to attend the AGM but am willing to answer any questions members would like to


email me before or after the meeting. I'm most grateful to Luke for inspecting the books and confirming all

this money does actually exist. One final plea is for members to pay subs promptly, preferably by bank transfer or standing order/regular payment. Chasing money is not my favourite occupation on a Wednesday night. I will send you an email after the AGM confirming the amount of subs due (unless changed by the AGM), but to recap its £90 for the year with a 50% discount for concessions (OAP, children and unwaged) and a further 20% discount for multiple family memberships.
